Important Issues to Notice!

Filing of House Bill 45, House Bill 47, & House Bill 83 in 2019

Legislator

- ❖ **House Bill 45:** “Hands Free Florida” addresses the importance of road safety regarding texting and driving. This bill prohibits any operation of a motor vehicle while holding or touching wireless communication devices. This will ensure less distractions and prevent further tragedies from happening on our roads, keeping our citizens safe.
- ❖ **House Bill 47:** “Reporting Animal Cruelty” addresses if a veterinarian has any suspicion of any form of animal abuse, they can report it to a law enforcement agency and are immune to a lawsuit from such action. This will help all animals who have been neglected by their owner and provide them with a safer environment. I understand that a veterinarian feels they are at risk when filing a report to law enforcement and this bill will protect the professional from any negative consequences when doing so.

Sexual Assault Offenses

- ❖ **Sexual Battery Offenses:**
 - No victim of sexual assault should go unheard. I filed HB 83 that will increase the statute of limitations to 15 years and will also allow victims of crime to track the DNA kits through the process.
