

Alliance Spoke and Solid Waste Authority Listened

The Alliance of Delray spoke at the August 29, 2018 meeting of the Solid Waste Authority where proposed changes to Palm Beach County's garbage disposal contract were discussed.

One proposal considered was a change from twice a week trash pick-up to once a week. Alliance President Bob Schulbaum brought hundreds of e-mails for submission and echoed the overwhelming request of the Membership to maintain trash pick-up twice weekly. Automation was another item discussed. With automation would come trash containers specifically designed for grasping the containers and dumping the garbage into the truck. The trash containers could be as large as 96 gallons, but could also be smaller.

President Schulbaum noted that trash removal is a necessity, not a luxury for those that require certain health, wellness, and hygiene supplies vital to their daily physical needs. These items must be cleared from the home frequently.

Executive Vice President Lori vinikoor explained that Palm Beach County has lush vegetation that requires frequent extensive trimming. The amount of yard waste currently allowed to be placed at curbside is based on that understanding and must remain the same. If decreased, property owners will need to warehouse trash and yard debris, causing potential fire hazards and pest infestation. She also mentioned that legislative changes to Condo and HOA statutes might be considered in order to allow for outdoor placement of the newer trash receptacles required to be utilized with automated trucks as opposed to simply placing bags at the curb.

The result of the meeting: twice a week garbage service with a six day service schedule remains along with the hauling of 6 cubic yards of vegetation per week. Bulk pick-up will be once a week, three items. The contract bids will include automated/semi-automated service.
