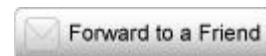

More than a dozen nonprofits are being aided by the generosity of Clerk & Comptroller employees, who donated an impressive \$50,000 to charitable causes this year.

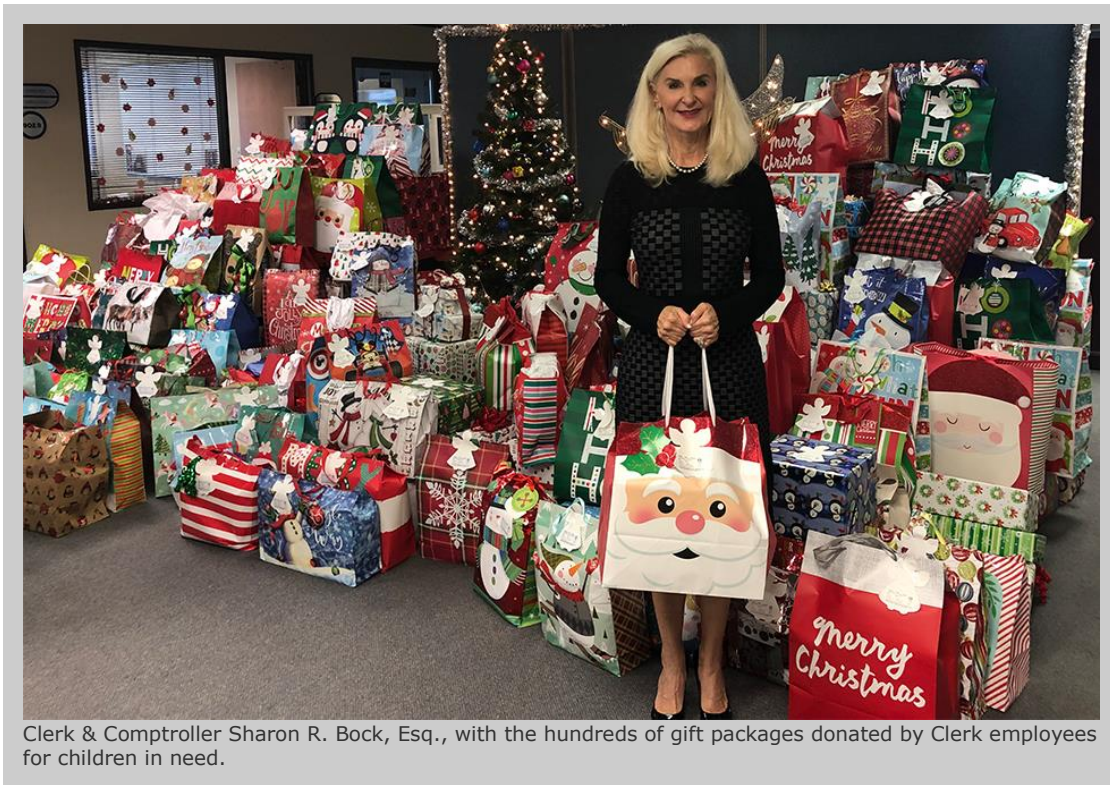

Clerk's Office Recognized for Fiduciary Excellence

For the tenth consecutive year, the Clerk & Comptroller's office has distinguished itself as a global leader in fiduciary excellence for its management of Palm Beach County's \$2 billion investment portfolio.

The Clerk's office last month was again certified by the [Centre for Fiduciary Excellence \(CEFEX\)](#), a designation that reaffirms that the Clerk's office is operating using the best practices in the investment industry.

During Fiscal Year 2018, the County's portfolio generated \$34 million in investment income, a 21 percent increase over the previous budget year. That amounts to a return of roughly \$53 for every Palm Beach County taxpayer.
