Beginning July 1, texting while driving is a primary offense in Florida. In this issue, learn how the law will be enforced and the penalties drivers face if they are caught texting while driving.

## New Texting While Driving Law Takes Effect July 1

On July 1, Florida becomes the 44th state to make texting while driving a primary offense, meaning law enforcement can stop drivers solely for texting behind the wheel of a moving vehicle. Drivers are required to go totally "hands-free" in school zones and in construction zones when workers are present. Drivers will still be able to use their phone while their car is stopped.

The penalty for a first offense is \$30 plus court costs. A second offense is a \$60 penalty plus court costs and three points on the driver license. A crash resulting from texting would result in six points on a driver license. Drivers with additional points can have their license suspended. There will be a grace period through January to help inform motorists of the new law. Warnings will be issued during this time.

## **Renew Your Local Business Tax Receipt Online**

Business owners can renew Local Business Tax Receipts (LBTR) from July 1 through Sept. 30. Avoid crowded offices, renew your LBTR on our website at <u>www.pbctax.com</u>.

Here are a few helpful tips for business owners:

- Sale of Business If you sell your business, transfer the LBTR to the new owner. You must provide a bill of sale to the new owner and surrender the current original receipt to our office. The new owner will pay a transfer fee.
- Out of Business If you close your business, please notify us immediately by emailing <u>ClientAdvocate@taxcollectorpbc.com</u> or complete and sign the "out of business" portion of your Local Business Tax Notice payment stub. Mail the stub to: Palm Beach County Tax Collector, P.O. Box 3353, West Palm Beach, FL 33402-3353.
- **Relocate Business** If you relocate your business, transfer your LBTR. You must complete a new LBTR application, provide proof of zoning approval (if required) and surrender the current original receipt.
