Do You Have Unclaimed Funds?

Check the Clerk & Comptroller's list of thousands of dollars in unclaimed money. The Clerk's office collected these funds prior to Jan. 1, 2018.

Funds must be claimed on or before September 3, 2019 (in person at the courthouse by 4 p.m. or electronically filed by 5 p.m.). Claims filed after September 3, 2019, will not be processed and such funds will be forfeited. [Learn more.](#)

Groundbreaking Program Helps Keep Residents in the Driver's Seat



The [Clerk's Court Compliance program](#) helps people establish reasonable payment plans for their court obligations.

Over the last four years, the program reduced driver's license suspensions for failure to pay criminal fines and fees by 85 percent. Suspensions for traffic violations dropped 35 percent.
