Clerk's Operation Green Light Helps Hundreds of Drivers Get Back on the Road



October 2019

More than 1,500 drivers throughout Palm Beach County were cleared to get back on the road during Operation Green Light – a special driver license reinstatement event hosted by the Clerk & Comptroller's office.

During the special event:

- 1,381 people were cleared to reinstate their driver licenses
- 196 driver licenses were reinstated
- 1,020 court cases were paid in full
- 3,719 cases were placed on a payment plan
- More than \$422,000 in fines and fees was collected
- Payment plans totaling \$2.3 million were established to pay off overdue traffic tickets and court fines
