<u>Rep. Frankel Holds Listening Roundtable with Health Care</u> <u>**<u>Professionals</u></u></u>**

The Congresswoman hosted a listening roundtable with healthcare professionals from South Florida to hear about pressing issues facing physicians and patients.

As a member of the Appropriations Committee, the Congresswoman oversees funding for the Department of Health and Human Services, which manages some of the nation's most critical health programs including the National Institutes of Health (NIH), Medicare, Medicaid, the Children's Health Insurance Program (CHIP), and services that promote public health and safety. The Congresswoman was joined by local physicians, nurses, home healthcare workers, and other medical professionals.

<u>Rep. Frankel and Colleagues Send Letter Supporting Youth</u> <u>Caregivers</u>

The Congresswoman and 23 Members of Congress sent a letter to the Administration for Community Living requesting the Family Caregiving Advisory Council consider the needs and perspectives of youth caregivers. There are at least 1.3 million caregiving youth in the United States ages 8-18 years old. These youth provide significant assistance, sometime alone, to relatives or family members who need support because of chronic or terminal health conditions. The academic, physical, developmental and emotional impact of caregiving on youth is often hidden behind closed doors, and they often lack the support they need to succeed. The Congresswoman visited with some of these youth caregivers and their families in her district at the American Association of Caregiving Youth founded by Connie Siskowski, RN, PhD, who also serves as the President.

"Youth caregivers deserve a normal childhood and a bright future, said the Congresswoman. We need to acknowledge the unique challengers this community faces and find ways to support them."
