Florida's 2020 regular legislative session starts on Tuesday, Jan. 14, and I'm proud to be championing mental health priorities this session, including HB 939 establishing medical insurance parity for mental health and substance abuse disorders. You Can't Vote If You Aren't Registered

Florida's presidential preference primary will be March 17, 2020. To vote you must be registered at least 29 days before the date of the election in the political party for which the primary is being held. If you are new to Florida or your address has changed, call the Supervisor of Elections office at (561) 656-6200 or go online at <u>www.pbcelections.org</u>. As long as you have access to a computer, the <u>www.pbcelections.org</u> website is designed to give you all the information you need for Palm Beach County voting, whether you are asking for a vote-by-mail ballot, wanting to work at the polls or are interested in voter and election statistics.


