COMMON QUESTIONS AND ANSWERS ABOUT UNEMPLOYMENT

1. What is the latest on whether a claimant will be paid based on retroactivity?

We should expect to see a rule this week on retroactivity, however, an effective date has not been chosen yet. From what we are hearing, the retroactivity will NOT be to the date of job loss but the date the applicant TRIED TO APPLY. This will mean applicants will have to "self-report" the date they first tried to apply.

2. Have the bi-weekly reporting requirements been waived? If not, when will they be?

This rule is, in fact, waived for everyone. The waiver will be in place until further action from the Governor or would at most be commensurate with however long order 20-52 (the emergency declaration) is in place.

3. Can those who qualify for PUA (pandemic unemployment assistance) be provided a separate application process (or be integrated into a single application process) that does not require them to first apply for traditional RA? How soon will that application be available?

The DEO does not yet know when an application for PUA ready (self-employed applicants or independent contractors/gig workers) will be available but we are told that there should be guidance on this coming this week.

Once the application is available, self-employed applicants or independent contractors/gig workers will be quickly routed to the PUA application and not be required to apply for traditional RA first and fail before being routed to the PUA application.

4. Will the suspension of work search be extended?

It is expected that the waiver of the work search requirements will be extended past May 2 but ultimately, it is the Governor's decision.

5. Is there anything I should know in order to speed up my application?

Unfortunately, no. The only tip relayed is to use the online application system wherever possible instead of the paper application system.

6. When can we expect an accessible and fully functioning online and telephone application process?

Efforts are being made to staff calls and improve capacity. The DEO is also working with the U.S. Dept. of Labor to streamline components of the verification process.

7. PIN reset information

Soon an online PIN reset feature (instead of via phone) should become available.

Additionally, waiving the re-certification requirement removes the need for a PIN once someone starts receiving benefits; this should significantly reduce call volume.

DEO is seeing historic increases in Floridians filing for Reemployment Assistance and has received 1,533,723 applications for Reemployment Assistance from March 15 through Sunday, April 19. This number includes multiple duplicates and triplicates due to many individuals filing directly in CONNECT, online and by paper. We are going through the process of identifying duplicates and triplicates; and currently have 652,191 confirmed unique claims of the total claims submitted.

*Florida Reemployment Assistance claim numbers are not official until the <u>U.S. Department of Labor</u> releases them each Thursday at 8:30 a.m.

Technology Enhancements

Over the weekend, DEO conducted necessary upgrades to enhance the performance capability of CONNECT. These upgrades are allowing the system to process claims faster so that individuals filing for Reemployment Assistance can be paid as soon as possible.

DEO will be conducting nightly maintenance to the CONNECT system to help with processing claims. CONNECT will only be available from 8 a.m. – 7:59 p.m. daily.

Importantly, this will not affect individuals that are filing a new claim. Individuals can file a new claim 24 hours a day, seven days per week, please click here.

Waiving Red Tape

At the Direction of Governor DeSantis, Secretary Satter is working with the United States Department of Labor to identify any regulatory burdens that can be waived to ensure that claims are processed and paid quickly. Additionally, Governor DeSantis has suspended the bi-weekly reporting requirement. This means individuals do not have to log into CONNECT every two weeks to claim your weeks of reemployment assistance.

CARES Act Update

The Federal Pandemic Unemployment Assistance (PUA) provides unemployment benefits to those that may not otherwise be eligible for regular Reemployment Assistance benefits. This includes individuals who are self-employed or independent contractors. DEO will provide more information on PUA and how to apply in the coming week.

Q. Who do I call if I have questions?

A. Unemployment compensation is administered by the Department of Economic Opportunity (DEO). Their helpline is (800) 204-2418. Although CareerSource Palm Beach County has no control over these state services, we may be able to answer some of your immediate questions. Call us at (561) 340-1060 and press option 6.

Q. What information do I need to file for unemployment compensation?

- A. You will be required to provide the following information, so have it handy when you begin your application:
 - · Social Security Number
 - · State driver's license or ID
 - Last 18 months' employment information
 - o Employer's name, address, telephone number
 - o Employment start date and end date
 - Gross earnings
 - Reason for separation
 - Work Authorization (if not U.S. Citizen)
 - DD-24 for Military
 - SF8 or SF50 for Federal Employees

Q. The Connect system is very slow and/or keeps dropping me out. What can I do?

- A. During regular business hours, access to the Connect system is at peak demand. Try filing your unemployment application in the early morning or late evening.
- Q. The system is asking me for a pin number. What should I do if I can't remember my pin number or it needs to be reset?
- Call (800) 297-0586, but be prepared for a long wait when call volume is high. You may also do
 this online at www.FloridaJobs.org/COVID-19
- Q. Does the state have a help line?
- A. Yes, for general information or to authenticate identification call (800) 204-2418.
- Q. What about help for those that only speak Creole or Spanish?

- A. Call (800) 681-8102.
- Q. How can I be expected to do 5 job searches per week to receive my reemployment compensation when most businesses are closed?
- A. Due to the current COVID-19 crisis, the Governor of Florida has waived the work search and work registration requirements for individuals requesting Reemployment Assistance benefits. For more information, see the Reemployment Assistance Frequently Asked Questions.

visit https://summerbreakspot.freshfromflorida.com/. The U.S. Department of Agriculture (USDA) has provided a waiver to allow parents/guardians to pick up meals without the child being present. The parent needs to provide confirmation of the number of children for which they are picking up meals, by one of the following methods: student ID, student passport, student library card, student birth certificate, or a photo of the adult picking up the meals with the students for whom they are picking up meals.

The parent will show the identification to staff providing the meals, and meals will be provided for the number of children identified. The District follows food distribution rules as outlined by the USDA.

To limit person-to-person contact, please remember to adhere to social distancing. *Those driving to one of the feeding sites are asked to open the*

trunk of their car or leave a seat open where staff can place the food. People walking up to a site should remember to maintain a distance of at least six feet.

These measures are taken very seriously and are intended to keep everyone safe.

Meals provided may vary by location and may contain allergens. Adults picking up the food are asked to be vigilant and ensure they do not take food if allergies may be a concern. Food should be refrigerated or discarded if not consumed upon receipt.

Use of Cloth Face Coverings to Help Slow the Spread of COVID-19

How to Wear Cloth Face Coverings

Cloth face coverings should-

- · fit snugly but comfortably against the side of the face
- · be secured with ties or ear loops
- · include multiple layers of fabric
- · allow for breathing without restriction
- be able to be laundered and machine dried without damage or change to shape

CDC on Homemade Cloth Face Coverings

CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies), **especially** in areas of significant community-based transmission.

CDC also advises the use of simple cloth face coverings to slow the spread of the virus and help people who may have the virus and do not know it from transmitting it to others. Cloth face coverings fashioned from household items or made at home from common materials at low cost can be used as an additional, voluntary public health measure.

Cloth face coverings should not be placed on young children under age 2, anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the cloth face covering without assistance.

The cloth face coverings recommended are not surgical masks or N-95 respirators. Those are critical supplies that must continue to be reserved for healthcare workers and other medical first responders, as recommended by current CDC guidance.

Should cloth face coverings be washed or otherwise cleaned regularly? How regularly?

Yes. They should be routinely washed depending on the frequency of use.

How does one safely sterilize/clean a cloth face covering?

A washing machine should suffice in properly washing a cloth face covering.

How does one safely remove a used cloth face covering?

Individuals should be careful not to touch their eyes, nose, and mouth when removing their cloth face covering and wash hands immediately after removing.

Sewn Cloth Face Covering

- Two 10"x6" rectangles of cotton fabric
 Two 6" pleces of elastic (or rubber bands, string, cloth strips, or hair ties)
- Needle and thread (or bobby pin)
 Scissors
 Sewing machine




Tutorial

Cut out two 10-by-6-inch rectangles of cotton fabric. Use tightly woven cotton, such as quilting fabric or cotton sheets. T-shirt fabric will work in a pirch. Stack the two rectangles; you will sew the cloth face covering as if it was a single piece of fabric.



Fold over the long sides ¼ inch and hem. Then fold the double layer of fabric over ½ inch along the short sides and stitch down.



3. Run a 6 nich length of 1/8-inch wide elastic through the wider hem on each side of the cloth face covering. These will be the ear loops. Use a large needed or a bobby pin to thread it through. The tend sight.




Gently pull on the elastic so that the knots are tucked inside the hem.
 Gather the sides of the cloth face covering on the elastic and adjust so the cloth face covering fits your face. Then securely stifts the elastic in place to keep it from slipping.
