# **Palm Beach County Approves Restart Business Grants**

The Palm Beach County Board of County Commissioners (BCC) approved the CARES Restart Business Grants Program to accelerate the reopening of businesses hardest hit by COVID-19.

The \$60 million Business Restart Program uses a portion of the county's \$261 million allocation from the Federal CARES Act approved by Congress. The BCC has dedicated \$50 million toward businesses with 25 or fewer employees and \$10 million towards businesses with greater than 25 employees.

The program guidelines, including eligibility criteria, are currently posted on the County's website ([www.pbcgov.org](http://www.pbcgov.org)). The BCC gave approval for individual grants up to \$25,000 to help Palm Beach County businesses forced to close or limit operations and are now planning to "restart" based on the county's phased opening process.

Required documents will include a fully executed application from the county's online portal, certifications, affirmations and acknowledgements, tax returns, payroll reports, an active Palm Beach County Business Tax Receipt, and an active registration on SunBiz. These documents will be required to be uploaded into the system by the applicant.

Interested businesses are encouraged to prepare for the Restart Program Application as they will be processed on a first come, first eligible basis. The online application is expected to launch on Friday, May 22, 2020 at 8:00 A.M. and will be accessible through the Palm Beach County website.

## **Hurricane Preparedness:**

Hurricane season begins June 1, 2020 and ends November 30, 2020. I want to share with you some preparation recommendations issued by Palm Beach County. ### **1 Month Before Hurricane Season**

- Complete the assembly of your Emergency Supply Kit. **Be sure to include face masks!** Purchase medicine last.
- Check with your doctor/pharmacy to determine how best to assure your prescriptions will last through a storm.
- If you need to register for the Special Needs Shelter, contact the Special Needs Coordinator at 561-712-6400.

### **Pet Safety**

- Have a plan for your pets if you are evacuating and not taking them with you. Have them stay with friends or family who are not evacuating, or board them with a local facility or your veterinarian.
- Make sure your pet has a collar with a contact name and phone number.
- The Pet Friendly Shelter is located inside the West Boynton Recreational Center at 6000 Northtree Blvd., Lake Worth, FL 33463 and is only available to Palm Beach County residents who reside in a mandatory evacuation zone, in a mobile home, or in substandard housing. Proof of residency will be required.
