- Beginning Monday, July 6, the request to modify the effective date will no longer be available online, but instead need to be made by calling 1-833-FL-APPLY (1-833-352-7759) and choosing option 5.
- Please be aware that the work search and work registration requirements for claimants expires Saturday, July 4, 2020, unless the Governor directs DEO to extend it.
- Palm Beach County & Broward County have implemented mask requirements.

HOW DO I REPORT A BUSINESS THAT ISN'T FOLLOWING COVID-19 ORDERS?

BROWARD COUNTY

Broward residents can anonymously report violations by following these steps:

ONLINE

- · Go to MyBroward.Broward.org
- · Select "Request for Service"
- Enter the location of the violation, and select "COVID-19 Business Complaints" as the Type of Issue.
