# HOW DO I GET TESTED IF I AM HOMEBOUND OR UNABLE TO ACCESS A DRIVE-UP OR WALK-UP TESTING SITE?

#### **BROWARD COUNTY**

Broward County, in partnership with other entities, offers residents the ability to use a mobile, in-home testing program. It is a service for homebound elderly or disabled individuals who are experiencing symptoms of COVID-19 and cannot leave their homes to access testing sites. The Call Center is open from 8AM to 6PM seven days a week.
