## Vaccine Eligibility Expanded to Include Educators, Law Enforcement Officers, and the Medically Vulnerable

Pursuant to a new Executive Order by Governor Ron DeSantis, educators, law enforcement officers, and medically vulnerable persons are now eligible to receive the COVID-19 vaccine.

The populations currently eligible to receive the COVID-19 vaccine are as follows:

- Long-term care facility residents and staff;
- Persons 60 years of age and older;
- Health care personnel with direct patient contact;
- Persons under 65 deemed to be medically vulnerable by a physician ([form required](#));
- K-12 school employees 50 years of age and older;
- Sworn law enforcement officers 50 years of age and older; and
- Firefighters 50 years of age and older

We will continue to keep you updated as we get more information on the expanded eligibility criteria.
