ALL FLORIDIANS over 18 years old are eligible to receive any COVID-19 vaccine as prescribed by the Food and Drug Administration.

Sixteen and seventeen-year-olds are eligible for the Pfizer vaccine.

- 1) The Veterans Administration will vaccinate veterans of ALL ages who currently receive care at the VA;;

Economic Stimulus Payments:

Anyone who filed 2018 or 2019 tax return or who receives SSDI will automatically get a stimulus check. If you did not fire a tax return, you must file a form with the IRS first: https://ww.irs.gov/pub/irs-pdf/f8822.pdf.

If you did not file a tax return in 2018 or 2019 and/or had zero income, you must first file a form with the IRS: irs.gov/newsroom/economic-impact-payments-what-you-need-to-know.

Reimbursement to Health Care Providers and Facilities for Testing, Treatment and Vaccine Administration for the Uninsured

Providers who have conducted COVID-19 testing to uninsured individuals, provided treatment for uninsured individuals with a COVID-19 diagnosis on or after February 4, 2020, or administered COVID-19 vaccines to uninsured can begin the process to file claims for reimbursement: coviduninsured claim.linkhealth.com.

COVID-19 Funeral Assistance

FEMA will begin accepting applications for COVID-19 funeral assistance in April. The types of documentation you will need to apply are:

- a) An official death record, which attributes the death directly or indirectly to COVID-19 and that show that the death occurred In the United States, including the District of Columbia and U.S. territories.
- b) Funeral expenses, such as receipts and a funeral home contract.
- c) Proof of funds received from other sources, specifically for the use toward burial or funeral insurance. FEMA is unable to duplicate benefits received from burial or funeral insurance or financial assistance received from other sources.

Emergency Rental and Utility Assistance

The Palm Beach County Community Services Department opened its online portal for Emergency Rental Assistance and Utility Assistance on March 10th. The portal is currently closed but will open again once current applications are processed

Eviction Assistance III Program

Legal Aid of Palm Beach County just opened its Rapid Response Eviction Assistance III Program. This program is specifically for undocumented individuals located within Palm Beach County. Legal Aide will provide legal representation and rental assistance to undocumented tenant

households that have experienced loss of income, reduction in hours or unemployment as a result of the COVID-19 pandemic.
