JOHNSON AND JOHNSON VACCINE

As recommended by the CDC and FDA, distribution of the Johnson & Johnson COVID-19 vaccine is being paused to allow for review of a small number of cases of blood clots experienced by vaccine recipients. The Health Care District of Palm Beach County and local Health Department use of this vaccine is on hold pending further notice from the CDC and FDA. Strike team pop-up vaccination sites under the direction of the Florida Department of Health, including an event at Wellington Mall today and one in Royal Palm Beach tomorrow, are also temporarily suspended in response to this notice. Distribution of the Pfizer and Moderna vaccines is unaffected by this action.

***NEW* Health Care District's Pfizer COVID-19 Vaccination Appointments Available with No Wait Times**

The Health Care District of Palm Beach County encourages individuals 16 years and older to self-schedule their first-dose appointments for the Pfizer vaccine online at <http://vaccine.hcdpbc.org> [vaccine.hcdpbc.org]. After opening over 16,000 first-dose appointments yesterday, there have been no wait times to schedule an appointment today. Appointment dates are available between Wednesday, April 21 through Thursday, May 6, 2021. Individuals 16 years and older are eligible to self-schedule appointments for the Pfizer vaccine brand.

The website <http://vaccine.hcdpbc.org> [vaccine.hcdpbc.org] lists the available dates, times, locations and eligibility requirements at each of the Health Care District's three mass vaccination sites at the South County Civic Center west of Delray Beach, the Burns Road Community Center in Palm Beach Gardens, and the South Florida Fairgrounds in suburban West Palm Beach. Individuals need to follow the state eligibility guidelines when scheduling to avoid being turned away at the sites. A parent or guardian must be present at the appointment of those who are 16 and 17 years old.

Berman's Bills Head to the Senate Floor

[SB](#) [184:](#) [Purple](#) [Alert](#)

SB 184 establishes a Purple Alert, which can be activated when an individual who falls in the parameters set forth goes missing and whose disappearance is a credible threat of immediate danger or serious bodily harm to themselves. This includes those with a mental, cognitive, intellectual or developmental disability or one with a brain injury or another mental, physical or emotional disability that is not related to substance abuse. The Bill passed in the Senate Appropriations Committee on Thursday 4/15 and is headed to the floor for a vote on Wednesday, 4/21.

SB 358: Water Safety and Swimming Certification for K-12

Asks parents of children entering any public or private school system to confirm that their child has had swimming lessons when entering the school system, and allows school authorities to identify students who may not know how to swim and will help put these parents in touch with free or low-cost programs to ensure their child has an opportunity to learn, presuming there is a desire. The bill was heard in the Senate Rules Committee on Friday, 4/16, and now heads to the floor.

SB 1070: Estates and Trusts

This bill creates the "Florida Uniform Directed Trust Act" addressing trusts that grant a trust administration power to a person other than a trustee, and create the "Community Property Trust Act" that allows spouses to transfer property into a Florida Community Property Trust. The bill was heard in the Senate Rules Committee on Friday 4/16 and passed. It heads to the Senate floor Wednesday.



Bills of Significance

CS/HB 1: Combatting Public Disorder

This bill has been highly publicized since Governor DeSantis announced it as a priority in the midst of summer protests for Black Lives Matter. After hours of debate, CS/HB 1 passed the Senate in a 23 to 17 vote. One Republican, Senator Jeff Brandes (R- St. Petersburg), defected from his party to oppose the bill with Democrats. This bill stifles and chills the First Amendment right to “free speech” and “assembly.” There are already sufficient laws on the books to criminalize violent rioters (assault, battery, theft, burglary) and law enforcement have multiple tools at their disposal to combat public disorder. By creating new offenses that are vaguely defined, and by enhancing penalties, CS/HB 1 will contribute to more arrests and criminal convictions, the vast majority of which will be plea agreements, staining records and further disenfranchising minorities. One new law the bill creates, mob intimidation, is so capacious, peaceful protests caught in the wrong crowd could face prosecution, even if they have no association with a violent perpetrator. The bill's effective date is upon the signature of the Governor.

CS/CS/SB 54: Motor Vehicle Insurance

This bill passed the Senate floor in a 38 to 1 vote. It repeals the Florida Motor Vehicle No-Fault Law (No-Fault Law), which requires every owner and registrant of a motor vehicle in this state to maintain Personal Injury Protection (PIP) coverage. Beginning January 1, 2022, the bill enacts financial responsibility requirements for liability for motor vehicle ownership or operation, as follows:

- For bodily injury (BI) or death of one person in any one crash, \$25,000, and, subject to the limit for one person, \$50,000 for BI or death of two or more people in any one crash.
- The bill sets a lower financial responsibility requirement of \$15,000 for BI or death of one person, and \$30,000 for BI or death of two or more persons, for persons having a household income of 200 percent or less of the federal poverty guidelines and for full time students attending a secondary or post-secondary school.

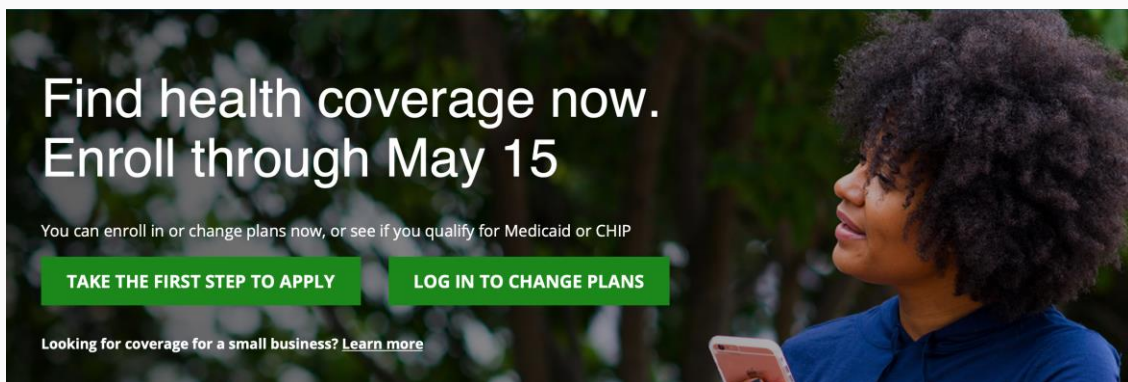
- The existing \$10,000 financial responsibility requirement for property damage (PD) is retained.
