Florida Legislative Session Update SB 90 Signed into Law

Florida's 2021 Legislative Session resulted in passage of a state budget and several bills impacting Floridians, as well as elections in our state.

Senate Bill 90 impacts 31 Florida Statutes relating to elections. Fortunately, the most disenfranchising proposals, such as banning the use of all drop boxes and cancelling existing Vote-by-Mail requests were not included in the final bill; however, many of the changes that passed will make requesting Vote-by-Mail ballots and returning those ballots more challenging for voters.

Currently, there are multiple lawsuits filed against Florida's state and local elections officials challenging Florida's new law. In the meantime, we can expect rule-making sessions with the State Division of Elections that will provide further implications and directions associated with the new law.

As your Supervisor, I will continue to make voting accessible to all voters while following any new requirements established by our lawmakers. I look forward to continuing to earn the trust of Palm Beach County voters while I work to maintain the integrity of our elections.

Special Election Update Congressional District 20

A special election to replace the late Congressman Alcee Hastings has been set by a Governor's executive order. The Primary Election for Florida's 20th Congressional District will be on November 2, 2021, and the General Election will be on January 11, 2022.

Voters living within the 146 participating precincts throughout Pahokee, Belle Glade, South Bay, Loxahatchee Groves, Haverhill, Mangonia Park, Glen Ridge, Cloud Lake, Lake Park, Riviera Beach, Royal Palm Beach, and West Palm Beach will cast their vote during the special election.

Additional voting precincts may qualify to vote in a special election should a current state legislator "resign to run" as a candidate for Congressional District 20, thereby creating a vacancy in their respective elected office.

We encourage the residents of Palm Beach County to keep their voter registration information up to date. If you are not sure whether you live within Congressional District 20, visit the My Status page of our website, enter your information, and select "Upcoming Elections" or "View Office Holders" under the voter information tab.
