2021 Special Session Update

Seminole Gaming Compact Passed by the Legislature

Last Wednesday marked the end of a brief but very busy special session focused on ratifying the proposed gaming compact between the Seminole Tribe and the State of Florida.

The Compact as approved by the Legislature is expected to bring in a guaranteed \$500 million per year for the next five years and more than \$6 billion by 2030. Under the Compact, the Seminole Tribe is expected to offer craps, roulette, and sports betting, in addition to slots, banked card games, raffles and drawings.

Together, the House and Senate passed <u>SB 2A</u>, which ratified and implemented the Governor's 30-year agreement with the Seminole Tribe on gambling and related topics.

Also passed during the special session were <u>SB</u> <u>4A</u> and <u>SB 6A</u>, which will establish the Florida Gaming Control Commission as the state's lead law enforcement agency on gambling. Under the measure, a five-member committee will have criminal justice authority over gaming laws and pari-mutuel institutions such as card rooms and horse racing.

The final proposal passed during the special session was <u>SB 8A</u>, which makes changes at racetracks and other gaming sites, allowing parimutuel facilities to convert solely to other forms of gambling.

While I do not believe the Compact was perfect, I believe it was a good deal for Florida's citizens
