UNEMPLOYMENT UPDATE FROM THE DEO

Florida is withdrawing from the Federal Pandemic Unemployment Compensation (FPUC) payments effective June 26, 2021. Pandemic Unemployment Assistance (PUA), Pandemic Emergency Unemployment Compensation (PEUC), and Mixed Earners Unemployment Compensation (MEUC) are set to expire on September 6, 2021.

REVIEW OF SPECIAL SESSION ON GAMING COMPACT

The Florida Legislature convened from Monday, May 17 through Friday, May 21 for purposes of ratifying the Gaming Compact between the state and the Seminole Indian Tribe of Florida. The individual bills can be found here. The Gaming Compact can be

Enclosed below are links that relate to the impact the Gaming Compact will have on our state. What remains to be seen, but is fully expected, is a constitutional challenge. Amendment 3, passed in 2018, requires the voters to decide whether or not gambling should be expanded. While the topic as a whole is very nuanced, I voted in favor of the bills as I feel, in the big picture, the state will benefit from the economic impact this deal secures. It is estimated that the compact will bring at least \$2.5 billion in revenue to our state in the first five years alone.

Has your K-5 student fallen behind in school from the "COVID slide?"

To address learning losses felt by the pandemic, the legislature passed language this year that authorizes parents to retain their K-5 student in their current grade level for the 2021-2022 school year, if academic reason can be provided.

- Parents wishing to retain their student must submit a written retention request to their school principal by June 30, 2021.
- The request will trigger a conversation between school leaders and parents to discuss retention and other supplemental support options, but the parents decision shall control.

According to the Census Bureau, a formula called the 'Method of Equal Proportions' is used to determine how many congressional seats a state has. As such, Florida will be gaining a new seat - but the question remains where and how it will be drawn.


After each decennial Census the Legislature redraws the districts from which Florida voters elect their state representatives, state senators, and members of the U.S. House of Representatives.

Your organization (and those you serve) will be the beneficiary of this infusion of manpower, creativity, connections, and effort. These projects will be highlighted in communications and events to our alumni throughout the year. Historically, the impact of these class projects has been significant and of lasting benefit to the participating organizations.

We will begin with two virtual collaborative workshops on June 8 and June 17 to review this opportunity, best practices, and create project ideas from your supplied issues, then how to generate successful project proposals. In order for your project to be considered for Engage Forward, at least one representative from your organization must attend one of these two workshops. Proposals are due back to LPBC no later than June 25. Proposals will then be judged by the alumni committee to be presented to the class. The class will then select the projects that they wish to support.


