COVID-19 Vaccination Announcements

- Executive Order 21-79 has expanded who is eligible to receive the COVID-19 Vaccination.
- The following are the updated eligibility guidelines:
 - Florida Surgeon General Dr. Scott Rivkees has issued a Public Health Advisory expanding vaccine eligibility to include non-Florida residents providing goods & services in Florida.
 - All Florida residents age 18+ are eligible to receive any COVID-19 vaccine.
 - The Pfizer vaccine is authorized for persons age 16 and up.
 - <u>*NEW*</u> The FDA has expanded the emergency use authorization for the Pfizer vaccine for adolescents aged 12-15.
 - Florida vaccine sites are still waiting on CDC and State approval to begin administering the vaccine to adolescents aged 12-15. This announcement should be coming this week.
 - All individuals under the age of 18 receiving a vaccine must be accompanied by a guardian and complete the COVID-19 vaccine screening and consent form. To download a copy of the form, <u>click here</u>.
 - The Moderna and Janssen (Johnson and Johnson) vaccines are authorized for persons age 18 and up.
- <u>*NEW*</u> The Biden administration has reached agreements with ridesharing companies Uber and Lyft to offer free rides to coronavirus vaccination sites through July 4, the White House announced Tuesday.
 - The free rides, starting in the next two weeks, are part of the Biden administration's push to administer at least one vaccine dose to 70% of U.S. adults by Independence Day.
 - A new feature will allow app users to "simply select a vaccination site near them, follow simple directions to redeem their ride, and

then get a ride to take them to and from a nearby vaccination site free of charge," according to the White House.

- <u>*NEW*</u> <u>Vaccines.gov</u> is a federally supported website that can connect you with vaccine sites in your local area.
 - <u>Vaccines.gov</u> helps you find locations that carry COVID-19 vaccines and their contact information. Because every location handles appointments differently, you will need to schedule your appointment directly with the location you choose.
 - COVID-19 vaccines are free and available to anyone who wants one. We work with partners such as clinics, pharmacies and health departments to provide accurate and up-to-date information about vaccination services in your area.
 - This page is brought to you by the United States Department of Health and Human Services, the Centers for Disease Control and Prevention (CDC), and VaccineFinder from Boston Children's Hospital.
- No Appointments required at DOH-Broward Sites
 - In an effort to eliminate any potential barriers to residents getting vaccinated, DOH-Broward no longer requires appointments for vaccination at any DOH-Broward operated site. Health Department staff is also looking into expanding operating hours at vaccination sites to better accommodate resident work schedules.
- Reverend Samuel Delevoe Park Now Giving Vaccines; No
 Appointment Required
 - Broward County's Reverend Samuel Delevoe Park at 2520 NW
 6th Street in Fort Lauderdale is now open as a public vaccination site. No appointment is required. For a full list of vaccination sites, visit <u>GetVaccinated.Broward.org</u>.
- Tune in at Markham Park
 - The DOH-Broward vaccination sites that are located in Broward County parks are introducing a new way of keeping residents that are in line waiting for their turn to be vaccinated informed about current conditions at the site. So far, the service has been

activated at Markham Park, and is expected to activate at other large park locations in the coming weeks. Meanwhile, if you are in your car at Markham Park waiting to get vaccinated, just tune in to 1120AM on your radio dial, and you'll get the latest information to help you through your vaccination experience.

- The City of Coconut Creek is offering free transportation to vaccination sites for select Coconut Creek residents. The free bus service provides transportation to and from the vaccination site at Broward College and will allow you to enter the facility on a priority basis. 
- The site opens at 8:30 am and closes once they have run out of their allotted vaccines.
- Health Care District's Pfizer COVID-19 Vaccination Appointments The Health Care District of Palm Beach County encourages individuals 16 years and older to self-schedule their first-dose appointments for the Pfizer vaccine online at <u>http://vaccine.hcdpbc.org</u>. Appointment dates are available through Thursday, May 6, 2021. Individuals 16 years and older are eligible to self-schedule appointments for the Pfizer vaccine brand.
 - For individuals who do not have internet access, please call (561) 804-4115 for assistance in scheduling a COVID-19 vaccine appointment. At this number, you can also reschedule or cancel previously scheduled appointments and receive assistance on any other issues related to the scheduling process.
- The Florida Department of Health in Broward County (DOH-Broward) is scheduling appointments via the State COVID-19 vaccine appointment scheduling system. You can call (866) 201-6313 to request an appointment. For those requiring TTY access, the phone number is (833) 476-1526.
- The West Palm Beach VA Medical Center is now offering COVID-19 Vaccine for ALL Veterans who receive care at the VA. The vaccine is offered by appointment and on a walk-in basis at Building 14 on the main campus in West Palm Beach, Monday-Friday from 10 am to 3 pm. The VA is offering the vaccine by appointment only at select CBOC's. Veterans must already receive care at VA to get the COVID-19 Vaccine and be able to return to the same site for their second dose.

State COVID-19 Announcements

- Governor Ron DeSantis has signed an executive order invalidating local emergency orders and COVID-19 restrictions.
 - This executive order supersedes a previous order that extended the state of emergency through June 2021.
- <u>*NEW*</u> Helping Floridians Get Back on Their Feet
 - OUR (Opportunities for Utilities and Rental Assistance) Florida Program is Florida's federally-funded emergency rental assistance relief program to support residents and businesses as they continue to recover and rebuild.

- The Small Business Administration will be launching the Restaurant Revitalization Fund to provide food and beverage businesses with funding to cover pandemic-related revenue loss of up to \$10 million. Recipients of funds will not be required to repay the loans as long as funds are used for eligible uses no later than March 11, 2023.

Palm Beach County COVID-19 Announcements County Updates

- In response to the Governor's <u>order 21-102</u> issued May 2, 2021, to suspend all local government mandates in place due to COVID-19 and in a continued effort to protect employees and the public, facial coverings or masks will continue to be required by employees and the public while conducting business in county buildings. The county will continue to follow all CDC guidelines and executive orders.
- Until further notice, it is the County's policy that individuals must wear a facial covering or mask and social distance from other individuals while indoors on County Property. County Property includes all County-owned and County-leased buildings where Palm Beach County's offices, divisions, departments or Constitutional Offices conduct business.
 - Further, in accordance with federal regulations facial coverings or masks are required on all county operated transit. Law Enforcement is authorized to issue a trespass warning and remove any individuals not in compliance with this policy.
- Mask requirements on Palm Beach County public school campuses and district property remain in place for both students and staff

members, as the policies do not fall under the jurisdiction of Monday's executive order from the governor.

- Emergency Rental Assistance and Utility Assistance: The portal is now open to accept applications for Rental, Relocation and Utility Assistance. Before you submit an application, please view this <u>video</u> to see if you qualify.
 - <u>UPDATE:</u> The application portal for Emergency Rental Assistance closes on Saturday, May 15 at midnight.
 - The application portal will re-open from June 7-15. Please note that the system will allow applicants to resubmit any documents requested by Case Managers.
 - The new Emergency Rental Assistance (ERA) funds will require more documentation than previous COVID funding. Please register for the "<u>Lunch-n-Learn</u>" webinar and read the <u>ERA FAQ</u>, to ensure you submit all of the documentation required to process your application successfully.

- Emergency Assistance to Homeowners in Palm Beach County:
 - The Palm Beach County Department of Housing and Economic Sustainability announces the availability of the Community Development Block Grant Coronavirus (CDBG-CV) Mortgage Assistance funds. This program will provide emergency financial assistance to <80% (or less) AMI homeowners who suffered adverse financial impact from COVID-19, and are delinquent in their first mortgage and escrow payments (PITI). Additionally, providing the homeowner is delinquent, funding may assist with second mortgages, late fees, condominium and homeowners' association payments, special assessments, and other mortgage associated costs related to COVID-19.
 - Up to 6 months of assistance (*not to exceed \$10,000*) will be provided to income eligible households who are at least onemonth delinquent (after February 29, 2020) in their home

mortgage, escrow payments (PITI) and/or condominium and homeowners' association payments. Assistance cannot be used to cover payments already made; and will be provided as a grant or a forgivable loan.

 All requests for assistance will be reviewed based on approved criteria. To qualify, all homeowners must demonstrate that the costs are directly tied to COVID-19. Additional criteria include but is not limited to: income eligibility, residence must be owner occupied, not under contract or listed for sale within the past 60 days, property must be in Palm Beach County, and the assessed value cannot exceed \$331,888.

 All applications must be submitted online and will be processed on a first come, first eligible basis.

- The online application will open on Friday, May 7, 2021 at 8:00 a.m., and close Monday, June 7, 2021 at 11:59pm.

- The Palm Beach County COVID-19 Education Compliance team is comprised of representatives from state and local agencies including the Palm Beach County Sheriff's Office, Palm Beach County Code Enforcement, Fire Rescue, the Florida Department of Health-Palm Beach County, and municipal police departments. Team members will proactively conduct spot inspections of local businesses and public venues, noting where masks are not being worn and/or social distancing is not being consistently practiced.

- The Palm Beach County Victim Services and Certified Rape Crisis Center staffs a 24-hour helpline, 561-833-7273, that is available every

day. Advocates are available to provide immediate support to victims of crime.

 Because of COVID-19, some individuals are fearful or reluctant to call the helpline, but residents should know that precautions are utilized to ensure the safety of victims and staff while services are provided.

School District Announcements

- The School District has opened the Going the Distance Together information Hotline, (561) 969-5840. The Hotline is open Monday through Friday from 8:00 am to 4:00 pm. The information is available in English, Spanish, and Haitian-Creole.
- The School District has launched an online dashboard to keep parents and staff informed of confirmed Covid-19 cases identified among individuals who were recently on District property. Click here: <u>PalmBeachSchools.org/Covad Dashboard [palmbeachschools.org]</u>
 - The dashboard is updated nightly with confirmed cases by date, school, and the number of students and employees affected. You will also find a link to the Covid-19 dashboard on the District's main webpage.
 - The District has worked closely with the Florida Department of Health and the Health Care District of Palm Beach County to supply principals with a COVID-19 toolkit and provide support with protocols, contact tracing, and communication.
 - Parents will be notified directly by the Health Department if their children have been exposed to someone with a confirmed case of COVID-19 on District property. Employees will be notified by Risk and Benefits Management if they have been exposed to someone with a confirmed case.
 - Very soon after that notification, a building-wide message will be sent to all parents and staff informing them of the case, and that if they didn't receive a letter from the Health

Department or Risk Management it is very unlikely that they came in contact with the individual with the confirmed case.

Testing Site Updates

- FITTEAM Ballpark of the Palm Beaches: Absolutely anyone is able to visit the testing site at the Ballpark of the Palm Beaches; you don't need to be symptomatic to be tested, but you need to state that you have been in contact with someone with COVID-19. Appointments are no longer necessary, tests will be administered on a first-come, first-served basis, and hours of operation have been expanded to 8:00 am to 4:00 pm.
 - Antigen (rapid) Testing is available at the FITTEAM Ballpark of the Palm Beaches testing site. <u>An appointment is not necessary</u>. Tests are available for all ages with symptoms. The site will be open Tuesday – Saturday from 8 a.m. – 4 p.m.

- Lakeside Medical Center in Belle Glade: This site offers walk-up testing. You do not need to be symptomatic but an appointment is required. Please call 561-642-1000 to schedule an appointment.

- The site is open by appointment only Monday through Friday from
 8:00 am to 12:00 pm.
- South County Civic Center Site, now closed for testing.
- FAU site: The testing site is located at the FAU Tech Runway on the north end of the FAU campus at 901 NW 35th Street, Boca Raton, 33431. Appointments are required for testing. To make an appointment, call 561-642-1000 Tuesday through Saturday from 8:00 a.m. to 2:00 p.m. Testing is available to anyone over the age of 12, with or without COVID-19 symptoms.
 - Drive-up rapid testing is available at Florida Atlantic University.
 - <u>An appointment is not necessary for rapid testing</u>. Tests are available for all ages with symptoms. The site will be open Tuesday – Saturday from 8:00 a.m. – 2:00 p.m. Test results will be text to your phone within 30 minutes.
- Town Center Mall in Boca Raton: Walk-up testing located at the Town Center at Boca Raton Mall, 6000 Glades Rd., Boca Raton, 33431, at the Sears parking lot. Testing every day, 9 a.m. – 5 p.m., free to any age, with or without symptoms. No appointment is necessary.
- CVS has expanded its testing sites and now includes the following locations near District 29:
 - o CVS Pharmacy, 520 S Federal Highway, Boca Raton, 33432
 - o CVS Pharmacy, 8954 Lantana Rd, Lake Worth, 33467
 - o CVS Pharmacy, 1690 S Federal Highway, Delray Beach, 33483
- Homebound Resident Testing: Residents eligible include homebound elderly or individuals with disabilities who are experiencing symptoms of COVID-19 and cannot leave their homes to access one of the drive-up or walk-up test collection sites. Residents who believe they are eligible for the in-home testing option should call 561-712-6400 for a pre-qualifying assessment. The testing line is open from 8 a.m. to 5 p.m. Monday through Friday.
- The Health Care District's C. L. Brumback Primary Care Clinics' site at the Delray Beach clinic is located at 225 South Congress Avenue.

Testing at this walk-up site is available by appointment Mondays through Fridays from 8 a.m. to 4:00 pm.

- Residents are encouraged to call the Health Care District's Testing Hotline, 561-642-1000, to schedule appointments at all of its testing sites. Testing is open to individuals of any age who do not need to be symptomatic
- Palm Beach International Airport: testing will be available in Helix Virtual Medicine's clinic located on the second level of the terminal near Concourse C. The clinic will provide passengers with results needed to comply with new pandemic-related travel requirements.
 - Testing is available from 9 a.m. to 5 p.m., Monday through Friday and on Sunday. Passengers must schedule an appointment for testing. Test results will be available to passengers within 24 to 48 hours for the standard PCR test. Patients will receive rapid test results in 30 minutes or less.
 - Passengers with proof of travel can take a PCR test for \$125.
 Travelers can be tested at the airport in the days leading up to their travel or after they disembark from a plane, and can bill their insurance for reimbursement.
 - On-site COVID-19 testing is meant for passengers traveling to and from PBI. Travelers should plan ahead to make sure they obtain the right kind of test for their needs, and allow adequate time for processing – usually three days before travel to destinations where a negative PCR test result is necessary.
 - Appointments for COVID-19 tests can be made at helixvm.com.
- AnyLabTest Now, located at 5175 West Atlantic Ave, Suite D, Delary Beach, is now conducting COVID anti-body test for \$70.00. You will receive your test results before you leave! Contact (561) 638-5227 for more information.
- NR Mobile will come to your home or office, anywhere in Miami-Dade, Broward, and Palm Beach counties to conduct either a COVID Swab or COVID Anti-Body test for \$150.00. For more information contact (954) 823-8501.

- Walmart has announced a partnership with Quest Diagnostics and the Department of Health and Human Services to bring new testing sites to South Florida. These drive-thru sites will be available at the pharmacy drive-thru windows at several Walmart Neighborhood Market Stores.
 - Appointments are required and can be made at www.MyQuestCOVIDTest.com. Any adult who meets CDC and state and local guidelines on who should be tested, including first responders, health care providers, and others with symptoms of COVID-19.
 - The closest site to District 29 will be located at the Walmart Neighborhood Market at 12700 S. Military Trail, Boynton Beach, FL 33436.
- MD Now is currently offering COVID-19 testing at certain Palm Beach County locations M-F from 8 am-4 pm. Please note appointments are REQUIRED and MD Now accepts most major insurances - you can visit <u>MDNow.com</u> for more information. The following locations are offering testing for people with MILD symptoms and first responders and/or healthcare workers without symptoms.

Municipal Announcements

- The City of Boca Raton has a Small Business Recovery Relief Grant program. The grant program is intended to provide eligible businesses who have been impacted by the COVID-19 pandemic with one-time grants of up to \$5,000. For more information, or to apply, <u>click here</u>
- The Village of Wellington is now accepting applications for Wellington's COVID-19 Temporary Rental and Utility Assistance Program. This temporary program funded by the Community Development Block Grant (CDBG) and CDBG's Cares Act provides a one-time rental and utility assistance to low and moderate-income Wellington residents who have experienced a loss of income, reduction in hours, or unemployment as a result of the COVID-19 pandemic.
 - Assistance is on a "first-eligible, first-served" basis.

Broward County Emergency Rent Assistance

- Broward County has funds available to help residents financially impacted by COVID-19 with rental and other assistance. The new COVID-19 Emergency Rental Assistance application portal is now OPEN and applying has never been easier. This program will pay 100% of rental and utility assistance for up to 12 months for qualifying households. Payments will be made directly to landlords and utilities. Call 888-692-7203 for more information.
- Community Development Block Grant (CDBG)
 - **Funds Availability:** April 1, 2020 thru March 31, 2023 or until funding is exhausted.
 - Purpose: Rent, Electric & Gas Utility Assistance
 - Eligibility Requirements:
 - Rent, electric and gas utility assistance may be provided for up to six consecutive months.
 - Applicant must provide proof of loss or reduction of income due to COVID-19.
 - Applicant must provide proof of current household income.
 - Applicant must provide late notices from landlord showing rents past due or provide a signed and dated general ledger from the landlord.
 - Section 8 customers are not eligible.
 - Applicant must provide most recent six months of bank statements.

Broward County Testing Site Updates

• **Quiet Waters Park:** The drive-thru testing site is testing asymptomatic adults and children. The site is operated in collaboration with FDOH and

the Broward Sheriff's Office and is located at 401 Powerline Road, Deerfield Beach. The site is open from 8:00 AM until 4:00 PM, Sunday through Thursday, and has a priority lane for testing of Broward County Public School children and staff. Testing is available to all ages, symptomatic and asymptomatic and pre-registration is not required.

- Mullins Park: The walk-up site is testing asymptomatic adults and children. This site is operated by the Florida Department of Health in Broward County and is located at 10000 Ben Geiger Drive, Coral Springs. The site open from 8:00 AM until 4:30 PM, Monday through Friday, and has a priority lane for testing of Broward County Public School children and staff. Please be sure to wear a facial covering when arriving for testing.
- Florida Panthers Ice Den: The walk-up testing site is open every day from 8:00 am to 4:00 pm. The site is located at 3299 Sportplex Dr, Coral Springs, which offers rapid testing ONLY. Results are provided via text or email.
- Mobile Testing: Broward County, the Florida Department of Health in Broward (FDOH-Broward), American Medical Response (AMR), and Century Ambulance Services (CAS) is operating a mobile/in-home testing program. Residents eligible for the new testing option include homebound elderly or individuals with disabilities who are experiencing symptoms of COVID-19 and cannot leave their homes to access one of the drive-up or walk-up test collection sites. Hours of operation are from 9:00 AM until 12:00 PM and 1:00 PM until 4:00 PM, Monday through Friday. For general information and homebound testing appointments, call 954-412-7300.
- Fort Lauderdale International Airport: The test collection site at Fort Lauderdale-Hollywood International Airport (FLL) is located in Terminal 3, pre-security, on the lower level near baggage claim. Follow directional signage. The site is open to consumers that can provide proof of travel plans to or from FLL on <u>any airline</u> – e.g. valid airline ticket, boarding pass or confirmed (paid) flight itinerary.

- There is a fee for testing at this site: \$106 for a PCR test; \$74 for a rapid (antigen) test. Credit and debit cards are accepted with a touch-free transaction and email receipt. Next-day results are available for PCR tests done before 4:00 pm; tests after 4:00 pm will have results within 48 hours.
- Normal operating hours are 7:00 am-9:00 pm daily. This site is operated in partnership with <u>Nomi Health</u>, <u>Spirit Airlines</u>, and Broward County Aviation Department. Appointments are required; for more information and to register, visit <u>Nomi Health's FLL</u> <u>weblink</u>. However, walk-ups may be accepted if no appointments are waiting for service.

Other Important Announcements

- The COVID-19 pandemic has brought overwhelming grief to many families. Under the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 and the American Rescue Plan Act of 2021, FEMA will provide financial assistance for COVID-19-related funeral expenses incurred after January 20, 2020.
 - To be eligible for funeral assistance, you must meet these conditions:
 - The death must have occurred in the United States, including the U.S. territories, and the District of Columbia.
 - The death certificate must indicate the death was attributed to COVID-19.

- The applicant must be a U.S. citizen, non-citizen national, or qualified alien who incurred funeral expenses after January 20, 2020.
- There is no requirement for the deceased person to have been a U.S. citizen, non-citizen national, or qualified alien.
- FEMA has begun <u>accepting applications</u>. If you had COVID-19 funeral expenses, we encourage you to keep and gather documentation. Types of information should include:
 - An official death certificate that attributes the death directly or indirectly to COVID-19 and shows that the death occurred in the United States, including the U.S. territories, and the District of Columbia.
 - Funeral expenses documents (receipts, funeral home contract, etc.) that includes the applicant's name, the deceased person's name, the amount of funeral expenses, and the dates the funeral expenses happened.
 - Proof of funds received from other sources specifically for use toward funeral costs. We are not able to duplicate benefits received from burial or funeral insurance, financial assistance received from voluntary agencies, government agencies, or other sources.

- The U.S. Small Business Administration (SBA), and the Treasury Department, announced the **Paycheck Protection Program** (PPP) has re-opened as of yesterday morning. New borrowers and certain existing


PPP borrowers will have access to capital from community financial institutions who were able to make <u>First Draw PPP Loans</u>, which started earlier this week, and <u>Second Draw PPP Loans</u> on today, January 13th, and participating lenders thereafter. The current round of PPP authorizes \$284 billion toward job retention, certain other expenses, and allowing certain existing PPP borrowers to apply for a Second Draw PPP Loan through March 31, 2021.

- Key PPP updates include:
 - PPP borrowers can set their covered period to be any length between 8 and 24 weeks to best meet their business needs;
 - PPP loans will cover additional expenses, including operations expenditures, property damage costs, supplier costs, and worker protection expenditures;
 - The Program's eligibility is expanded to include 501(c)(6)s, housing cooperatives, and direct marketing organizations;
 - The PPP provides greater flexibility for seasonal employees;
 - Certain existing PPP borrowers can request to modify their First Draw PPP Loan amount; and
 - Certain existing PPP borrowers are now eligible to apply for a Second Draw PPP Loan.


