First Responder Protection Legislation:

Representative Emily Slosberg
Files Bill for First Responder
Protection

Representative Slosberg filed <u>HB 127</u>, Transportation, entitled the First Responder Protection Act, which would strengthen existing protections for first responders under Florida's Move Over Law by prohibiting the handheld use of wireless communications devices while operating a motor vehicle in the immediate vicinity of an active scene where first responders are working.

Animal Welfare Legislation: Rep. Emily Slosberg plans to file a bill prohibiting unattended animal tethering

Representative Slosberg plans to file a House Bill which bans the unattended tethering of domestic dogs and cats as a means of confinement while unattended by an adult. The bill requires that animals be tied to a stationary or inanimate object with a rope, chain, or other means to restrict them be visible to and attended by a person. The bill also prohibits tethering during severe weather to ensure the health, safety and well-being of the animal. There
