Reps. Frankel, Deutch, Wasserman Schultz Host Holocaust Remembrance Day Roundtable



Representatives Lois Frankel, Ted Deutch, and Debbie Wasserman Schultz hosted a virtual roundtable honoring Holocaust Remembrance Day, which marks the liberation of the Auschwitz concentration camp. The conversation highlighted the importance of continued Holocaust education and informed Holocaust survivors and their families of the resources available to them in the Palm Beach County community. They also discussed the current threat of antisemitism in

communities across the United States and underscored the federal efforts that are underway to combat antisemitism and remember the tragedy of the Holocaust.

The panelists were also joined by special guest, **Halina Baumgarten**, a **Holocaust survivor**, who illustrated the importance of never forgetting the unspeakable tragedies of the Holocaust.

Reflecting on and recognizing the heroes that brought the Nazis to justice is paramount to remembering the Holocaust. With that in mind, Rep. Frankel introduced a bipartisan bill to award the <u>Congressional Gold Medal</u> to Benjamin Ferencz—a <u>101-year-old Palm Beach County resident who served as Chief Prosecutor in the Nuremberg trials</u>, where he secured the conviction of 22 former Nazi SS officials for their direct roles in the systematic murder of over a million Jews.



Rep. Frankel Announces Nearly \$1 Million for Palm Beach County School District for Violence Prevention Programs

Representative Lois Frankel hosted an in-person press conference to announce a nearly \$1 million grant that Palm Beach County School District will be receiving from the Department of Justice's STOP

School Violence Program to support evidence-based mental health programs to reduce violence in schools.

Rep. Frankel Promotes Funding for Green, Energy-Saving Buses in Bipartisan Infrastructure Law

Congresswoman Lois Frankel hosted an in-person press event to announce new grant opportunities for public transit systems, like Palm Tran, in the Bipartisan Infrastructure Law that will help provide

healthy, sustainable transportation options for millions of Americans. Specifically, Palm Tran would be able to use this new funding to expand its electric bus fleet and build new charging stations.

The Bipartisan Infrastructure Law makes a

historic investment of \$39 billion in public transportation, helping reduce greenhouse gas emissions by repairing, upgrading, and modernizing the nation's transit infrastructure. The funding includes \$3.1 billion for bus and facility grants and \$2.3 billion for low or zero-emission bus grants.

Rep. Frankel Highlights Urgency of Voting Rights Legislation on Anniversary of the Elimination of Poll Taxes

Representative Lois Frankel (FL-21) hosted a virtual press conference on the current state of American democracy and the importance of the voting rights legislation that has stalled in the Senate. The event took place on the anniversary of the ratification of the 24th Amendment in 1964, which finally eliminated poll taxes that were used to disenfranchise poor Americans and people of color by charging a fee to access the voting booth.

In 2021, 49 states introduced over 440 voter

restrictions—34 of which were signed into law. Earlier this month, the House passed the *Freedom to Vote: John R. Lewis Act* to fight back against this assault on democracy and ensure every American has the right to make their voice heard. However, Senate Republicans recently blocked the passage of this critical piece of legislation, trampling on the basic rights and needs of the American people.

Rep. Frankel and her guests discussed why continuing to fight to protect voting rights despite the Senate's actions is so critical for American democracy.
