We are currently awaiting budget updates from the Governor. We expect that any day now we will receive a budget veto list from him as well as a signed budget.

# HB937: PURPLE

### **ALERT**

#### SIGNED BY GOVERNOR RON DESANTIS

This bill addresses revisions to the purple Alert, a bill I previously sponsored. The bill requires a statewide Purple Alert be issued only when an identifiable vehicle is involved. The Florida Department of Law Enforcement will issue statewide alerts that include activation of dynamic messaging signs and lottery terminals, and notifications to subscribers.

If no identifiable vehicle is involved, dissemination of the alert will be limited to local distribution in the area where the person may be reasonably located. Local law enforcement would still be responsible for entering the case into the Florida Crime Information Center, notifying local media, informing all on-duty law enforcement officers, and alerting all law enforcement agencies having jurisdiction.

# Vote-by-Mail Ballots: Information from the PBC Supervisor of Elections

If you received a Vote-by-Mail ballot in 2022 and you have not renewed your request since November 9th, your mail ballot request has expired. New Florida Laws require voters who are interested in voting by mail to request a new mail ballot after each General Election cycle.

If you want to receive a Vote-by-Mail ballot for the 2024 elections, you will need to complete a new request.

There are two upcoming elections in 2024 in which voters will have an

opportunity to cast their ballot, including a Primary Election on August 20th, and the General Election on November 5th. The Presidential Preference Primary on March 19th will coincide with local municipal elections. If you want to vote by mail for any of these elections, please request your mail ballot today.

Middle school students are invited to participate in a one-week Reduce, Reuse, Recycle and Rethink (4R) adventure into the world of waste. The Solid Waste Authority of Palm Beach County's 4R Ambassador summer camp runs June 3-7,

## from 8:30 a.m. to 4:30 p.m. daily.

Campers will engage in hands-on activities and field trips to learn all about the environment from an integrated solid waste perspective. Activities will include behind-the-scenes access, allowing them to explore:

- a home chemical and recycling center that collects hazardous materials
- a landfill and its planet-protecting construction
- the Recovered Materials Processing Facility (recycling facility), where recyclables are sorted and processed for market
- Renewable Energy Facility 2, where trash is turned into electricity
- a transfer station, where garbage and recyclables are moved from small curbside trucks to larger tractor trailers
- the SWA Greenway Trail System and its wild inhabitants
- community partners, such as Resource Depot, Loxahatchee River District, and Grassy Waters Preserve

After students learn about the concept of "AWAY," they'll graduate as official SWA 4R Ambassadors. With this credential, they're encouraged to teach their family and friends how their waste behaviors can affect our environment.

The program is free; however, we encourage participants to bring an old electronic device to be recycled. Applications are due Friday, May 17, and will be reviewed on a first-come, first-served basis.

Students interested in the week-long summer camp must have:

• Completed grades 6, 7 or 8

- Minimum 3.0 GPA (transcript from school)
- Membership in a school club (Environmental, SECME, Garden, etc.) and a letter from its sponsor
- Recommendation letter from a science teacher
