Dear Friends:

August has arrived, and with it brings the official start of the 2026 election cycle here in Florida. This is an incredibly important time for our community, as the decisions made at the ballot box shape the future of Palm Beach County and our state.

Mark your calendars for two critical dates: the **Florida Primary Election on Tuesday, August 18**, followed by the **General Election on Tuesday, November 3**.

Your voice matters, and we want to ensure every eligible citizen has the opportunity to make it heard safely and conveniently. If you prefer to vote from the comfort of your home, I highly encourage you to request a Vote-by-Mail ballot today. As a reminder, Florida law requires voters to submit a new request for every two-year election cycle, so even if you voted by mail in 2024, you must renew your request for 2026.

The deadline to request a mail-in ballot for the Primary is **Thursday, August 6 at 5:00 p.m.** You can easily submit your request online or check your status by visiting the Palm Beach County Supervisor of Elections website at VotePalmBeach.gov.

Thank you for being an active, engaged member of our community. Let's make our voices count this election season!

"**Libertad**" features a powerful blend of mixed-media elements layered over a stylized backdrop of the American flag.

- "Adam and Eve" sculpture outside our Westlake Service Center.

TAX FREE HOLIDAYS



Mark your calendars, Florida families! Two major sales tax holidays are just around the corner. Whether you are prepping the kids for the classroom or gearing up for the great outdoors, you will want to take advantage of the upcoming Back-to-School and Hunting, Fishing, and Camping tax-free windows.

The Back-to-School Sales Tax Holiday is back with a brand-new timeline to better align with school start dates. The month-long event has shifted earlier, running from **July 20 through August 20**. This gives families plenty of time to shop before school is back in session. You can stock up on essential clothing, footwear, and backpacks (\$100 or less per item), school supplies (\$50 or less), and learning aids (\$30 or less). Personal computers and tablets up to \$1,500 also qualify.

The savings are just getting started. In honor of America's 250th anniversary, a massive four-month Hunting, Fishing, and Camping Sales Tax Holiday kicks off this fall, running from **September 1 through December 31**. It covers outdoor essentials, including tents,

sleeping bags, and fishing gear.

Lastly, there is a permanent sales tax exemption now in place for propane tanks (20 lbs. or less) along with a three-year tax freeze on hurricane-resistant windows and doors. For more information visit Florida Dept of Revenue, at www.floridarevenue.com/Pages/SalesTaxHolidays.aspx.
